### **CREWMEMBER SPOTLIGHT – provided by niece of ARLIE WILLIAMS**

A short Bio on my Uncle-Arlie Williams: He was born October 1918 in Corrigan, Texas, where he lived his entire life until he joined the Navy in 1935 or 1936. The only ship to which he was ever stationed was the USS Houston. He worked in the Soda Shop on the ship. He never married and had no children. His Mother was Amolisa Williams, and his sisters were Lena Faye and Mable Eddith (my Mother). He was loading shells into a gun that was mounted on the deck of the ship on the night of February 28th just before it sank.

**ABOUT THE PROJECT** – I've been sending gentle reminders to those on my email list to send Shawn the pictures and bio's. This is going to be the goal Otto and I have had for several years. It was taking Rachel Walsh (our volunteer that is legally blind) and myself long hours to scan one page at a time..... it's agonizingly slow! I wore out my scanner and had to break down to get another. They are much cheaper than days of yore & was able to get a combination fax, copy/printer and scanner that would do multiple scans at a time (about 25-30). Still, I had information from the 30's until current to scan. Then, everything fell together --- Shawn volunteered to put the scanned information together, Susan Krug offered to come to Texas and help, Sharron Long, Bridget McMaster & Pam Foster are helping Shawn. They were just waiting for Rachel & I to scan the rest of it. Susan Krug's son was gracious enough to get his mom the airline tickets and she arrived late afternoon May 10<sup>th</sup>. I gave her the tour of the office and outlined our work. The next morning we hit it with Susan in my office and I put the laptop and scanner/copier (donated by Susan & Larry Krug & used at the March reunions) on the kitchen table. We scanned hours on end for a week & were able to scan approximately 2,000 files. We now have over 3,000 files organized in folders and on disks!! I've got about 1/3 more to do and the job is done. This project will be incredible and the only one of it's kind for a veteran's organization! If anyone is interested in getting a copy of what I've got so far, you can write or call me (see # & address on front page). What's even more fantastic is it is the work of the Next Generation all on a volunteer basis. We've not only put our personal hours into this but they've added up to multiple weeks – safe to say months. Can you tell I'm excited, thrilled, and in awe of what has been done? So may to thank for so much done!!! We have available at this point: Ship's pictures, crew pictures and bios, Death Railway pictures, POW records, debriefings, Battle of the Java Sea information, Bluebonnets from the 30's to current, Ships logs from the '40 – '42, Changi prision information, POW camps info, personal statements (unclassified), action reports, Dive '05, Houston History, personal stories, History of the USS Houston (s): AK-1, CA-30, CL-81, & Saga of a Stout Ship story.

**P L E A S E** – WE NEED THOS PICTURES AND BIO'S! It may take a couple of hours of your time, but it's nothing in comparison to what these men went

through. Take the time to be sure these men are never forgotten. It's the least you can do for your loved one.

**DEBRIEFING BY LEON ROGERS** (date unknown) continued from last issue: The five of us were put in one cell and spent the night there, the only inmates in the jail. The next morning (March 5) Lt. R.R. Ross, U.S. Navy, was brought in with a party of about 25 men; part Houston survivors and part Perth survivors. I was kept in this jail for one week during which time Japanese soldiers brought in two or three prisoners almost every day. We were all given a thin straw mat to sleep on, one cotton shirt and a pair of cotton shorts. We had two meals a day consisting of a large helping of steamed unpolished rice and a small bowl of some kind of locally grown "greens". A doctor and a nurse from the local hospital came each morning and held "sick call". Most of the men had cuts and blisters on their feet; some had minor shrapnel wounds; several had great raw places under each arm from swimming in life jackets without shirts. Two Australians had been badly cut up by natives with machetes. All were confined in bare cells with wooden sleeping platforms and covered wooden tub for a toilet. The cells were designed for five native prisoners each and although there were as many as eight men in some cells none had to sleep on deck. Japanese soldiers made frequent inspections but did not stay at the jail. The native jailers continued to run the jail under Japanese supervision. With the exceptions of the meager diet, hard sleeping spaces, and poor toilet facilities, treatment in general was not too bad. There was adequate cold water for washing and sufficient boiled water for drinking. We were permitted out of our cells in the prison yard (behind high stone walls) a couple of hours in the morning and a couple of hours in the afternoon. During this time, we used the outside latrine consisting of a very faulty septic system and thus were able to reduce use of the wooden tubs in the cells to a minimum.

We had plenty of rest and sleep once we became accustomed to sleeping on wooden boards, but it was difficult to gain strength on the prison diet.

On March 11, there were 37 Americans in the Pandeglang jail. I was taken to Serang on this date along with 10 other Americans and a number of Australians. Here we were placed in the local jail where we found a large number of other survivors.

**FACTS ABOUT THE *HOUSTON CA-30*** – On board you could find a Barber Shop, Post Office, Library, Notion Store, General Kitchen (Galley), General Store, Clothing Store, Print Shop, Soda Fountain, Laundry, Telephone Exchange and Telegraph Office. There was a Power Plant capable of providing sufficient power which, if used for illumination purposes, could have supplied a string of street lamps placed 12 feet apart, reaching from San Francisco to Shanghai. The Distilling Plant converted sea water to fresh water with a capacity sufficient to provide each person of a city of 800,000 with a tumbler of water each day. The length of the *Houston* could be compared with the length of two football fields placed end to end or the height of a 48 story building. She had a Police

Force, Fire Department, Plumbers, Electrical and Telephone Service Men and others on duty at all times supervising public utilities..... alas, no air conditioning though.

**STAINED GLASS WINDOWS** – Meg Parkes of England writes “ I wish to inform your membership about a memorial project in England that will be of interest to them. I believe that some of the survivors were imprisoned in Java in '42 at a camp called Tanujong Piok near Batavia. In that camp the prisoners built a beautiful replica of an English church in reinforced concrete. One of the British Naval officers painted two exquisite mock stained glass windows which were set in the south wall behind the altar. These windows depicted the national flags and crests of Britain, Australia, Holland and the United States. They have survived for 63 years and are currently on display at the Anglican Church of All Saints in Jakarta.

Last summer I launched a national appeal here in Britain to raise funds to commission replicas of those windows. They will be placed in the South facing wall of the new FEPOW (Fare East POW) Memorial & Cultural building which will be officially opened August 15 at Alrewas, Staffordshire, England. 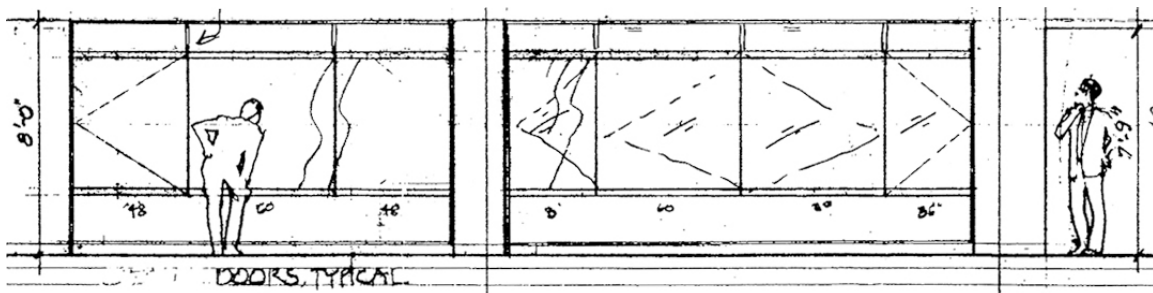
## USS *Houston* (CA-30) Exhibition Gallery

Plans are underway to begin installation of the paintings and other framed items that will be displayed in the new USS *Houston* (CA-30) Exhibition Gallery. The gallery, made possible by a generous donation from the Hamill Foundation, is located on the second floor of the library right next to the Administration suite. The gallery consists of two sets of exhibit cases, one which will hold framed items, and the other which will hold memorabilia. The cases holding framed items are along the walls which line the library's atrium, and should be highly visible to visitors to the library. These cases have sections which vary in size, the largest being 5 feet across, in order to hold different size paintings.

As soon as some unexpected electrical work is completed, a private art installation firm will come to professionally hang our amazing collection of paintings and other framed items related to the USS *Houston*. We are hoping this work will take place in July. The memorabilia cases will not be ready for a number of months because they are in an area that is still under construction. We anticipate that the entire exhibit will be ready in time for next year's reunion and library reception.

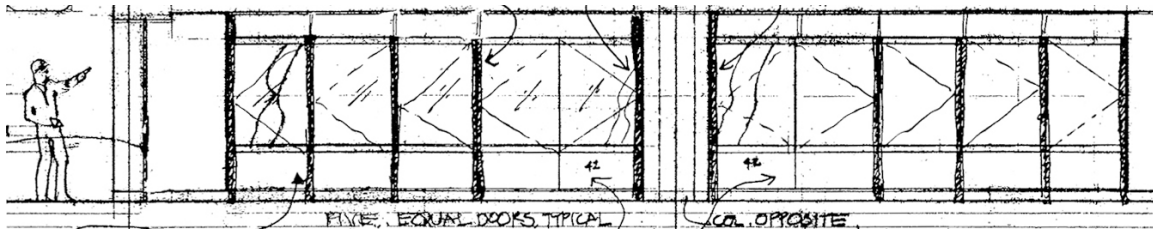
