U.S. Asiatic Fleet's U.S.S. Edsall has been Found!

On Monday, November 11, 2024, Remembrance Day in Australia and the UK and Veterans Day in the U.S., Australian and U.S. officials announced that H.M.A.S. *Stoker*, an Australian naval support ship, normally used for hydrographic surveys, had located the remains of the American WWII destroyer U.S.S. *Edsall* (DD-219). Approximately 300-feet long, U.S.S. *Edsall* was sunk in the Indian Ocean south of Java on March 1, 1942, after fighting alone against an entire Imperial Japanese fleet. For about an hour, the Japanese ships fired hundreds of shells at the *Edsall*, which managed to dodge all incoming fire. Finally, as evening fell, Japanese dive bombers were called in, and the doomed *Edsall* was struck by bombs, rolled over and sank. No crewman of U.S.S. *Edsall* was ever heard from again.


According to retired Rear Admiral Samuel J. Cox, Director of the Naval History and Heritage Command, the H.M.A.S. *Stoker* found the wreck of U.S.S. *Edsall* in the late summer of 2023 and examined it with underwater robots and sonar. The Royal Australian Navy notified Cox in May 2024 that it had found what it believed to be the *Edsall* wreck at 18,000 feet of water south of Australia's remote Christmas Island. Since then, U.S. Navy and Australian officials have worked together to confirm that the wreckage was that of U.S.S. *Edsall*.

U.S.S. *Houston* (CA-30) Survivor's Association's Historian Donald M. Kehn Jr. called the find "absolutely staggering." In 2008, Don wrote the definitive book on U.S.S. *Edsall*, <u>A Blue Sea of Blood</u>. —Dana Charles

# New U.S.S. *Houston* (CA-30) Display at NHHC Headquarters

Pictured at left is Rear Admiral (ret.) Samuel J. Cox, Director of the Naval History and Heritage Command (NHHC), standing beside the recently completed U.S.S. Houston (CA-30) artifact display now installed at the NHHC headquarters in Washington, D.C. This display, an Association-NHHC joint initiative, has been ongoing. Its completion includes a climate-controlled case funded by our Association, which contains the recovered trumpet and bell clapper previously donated to the U.S. Navy's Naval History and Heritage Command. The case also includes narratives explaining each of the displayed artifacts.

The display is positioned in the newly remodeled lobby area of NHHC headquarters at Navy Yard, Washington, D.C. A recently donated small-scale model of the USS *Houston* (CA-30) and a framed print of artist Tom

Freeman's famous painting of the CA-30 titled "They Sold Their Lives Dearly" round out the overall display. That painting depicts the USS *Houston* going head-on during the Battle of Sunda Strait on March 1, 1942.

Longer-range plans call for combining this display with the original shipbuilder's model of the USS *Houston* (CA-30), already on display at the Navy Yard, in a new National U.S. Navy Museum, which will be constructed at a nearby location outside the heavily secured grounds of Washington's Navy Yard complex.




The newly completed USS *Houston* (CA-30) display (top left) in the recently remodeled lobby of the NHHC Headquarters, Washington, DC, November 2024.

### **CREWMEMBER SPOTLIGHT**

## VERNON L. KOELLING, Mus2C, USN

For his last three years of high school, Vernon L. Koelling was a student in Waverly, Iowa, where he played on the football team and was an active member of the school band. During his senior year, Vernon enlisted in the U.S. Navy with the intention of pursuing a musical career after he graduated. By July 1940, he was undergoing training at the U.S. Naval Training Station in Great Lakes, Illinois.



Vernon completed his training and became a Navy musician. His favorite instrument was the French horn, but he could also play other instruments. For a short time, he served aboard the *U.S.S. Enterprise* and was transferred to the *U.S.S. Houston* in August 1941 to become part of its flagship band.


After the Japanese attacks at Pearl Harbor, the Philippines, and elsewhere, *Houston's* crewmembers were usually to be found manning their assigned battle stations. Vernon's was that of a loader for a .50 caliber machine gun atop the rear mast. The gunner was Vernon's friend, SEA2C Claude Washburn (known to the crew as "Sweet Pea"). Vernon and "Sweet Pea" Washburn were among those few who managed to reach shore on the night the *U.S.S. Houston* was lost in the Sunda Strait between Java and Sumatra. Imperial Japanese invasion forces captured both of them and initially held them in Serang, Java. After being moved to Bicycle Camp in Batavia, Java, the prisoners found living conditions were much improved, and the two shipmates were able to barter with local natives for food to supplement the meager Japanese rations.

After about seven months in Bicycle Camp, the Japanese began transporting allied POWS in the holds of hellships from Java to Changi Prison Camp at Singapore, Malaya. In January 1943, Vernon was among the Allied POWS of Group 5 who were transported to Burma to work on the infamous Burma-Thailand Railway construction project. Conditions were appalling in the jungles of Burma, and most of the men were ill at one time or another. Many would not survive.

In July 1943, Vernon suffered a slight injury to his leg, which became infected and developed into a tropical ulcer. When he became too ill to work, the Japanese transferred him to a railway hospital facility known as 80 Kilo Camp in Burma. Vernon passed away on September 11, 1943, and was buried in the camp's cemetery with appropriate religious ceremonies and an honor guard of his fellow POWs. "Taps" was played at the conclusion of the burial, and his grave was marked with a cross bearing his name. His POW record gives the location as grave number 78. After the war, Vernon's body was recovered and returned home to his family. His final resting place is at Harlington Cemetery, Waverly, Iowa.

# Middle & High School Presentations in Pennsylvania

On Thursday and Friday, November 7 and 8, 2024, Association member Blane Ampthor and I had some wonderful opportunities to address middle and high school students in Pennsylvania as part of special Veterans Day observances. On November 7, several local veterans from various military branches and Blane and I spoke at Tohickon Middle School in Doylestown, Pennsylvania, during the school's "Honors, Recognizes and Celebrates our nation's heroes for Veterans Day" program. Blane and I spoke about our respective fathers' WWII service.

Each of us—the local veterans, Blane and I—addressed five different middle school classes, with Blane presenting the story of his father, U.S. Navy WWII veteran Francis J. Ampthor, who served as an officer on U.S.S. *Missouri* and was aboard the ship on September 2, 1945, when the Japanese signed the surrender documents that ended the Pacific War. I delivered a PowerPoint presentation entitled "U.S.S. *Houston* (CA-30)/POW Experience" that highlighted the story of U.S.S. *Houston* (CA-30) and the subsequent POW captivity of my late father, Otto Schwarz, and his fellow 290 POW survivors.

On November 8th, at Council Rock South High School in Holland, Pennsylvania, some of Council Rock South's local veterans and Blane and I addressed five individual classes of high school students. Blane and I again presented the stories of our respective fathers' WWII experiences.

Blane and I are grateful to Dr. Matt Fash and his father, Jeff Fash, who invited us to participate in these speaking opportunities which enabled a younger American generation to hear these important stories. Jeff Fash, a teacher at Council Rock South for many years before his retirement, was a founding father of the concept for this program. Dr. Matt Fash established a similar program at Tohickon Middle School, where he currently serves as Assistant Principal.

Notes on news received via email at <a href="mailto:contact@usshouston.org">contact@usshouston.org</a> and via regular mail...

8/16/2024: Received the following email from VADM Ben Bekkering, Royal Netherlands Navy (Ret.), Chairman, the Karel Doorman Fund: "Dear friends, Fine greetings from The Netherlands, where yesterday evening, VJ-day, and all those who perished in the war in Asia were commemorated. The prime minister of The Netherlands attended, as did the ambassadors of the US, UK, Australia, New Zealand, and Indonesia. One wreath was laid by Mr. Johan Geneugten, who had 104 years under his belt and is the only living Dutch survivor from the battle of the Java Sea, where he was a sailor on board HNLMS Witte de With. His wreath was on behalf of



- all those military personnel who perished in action, during transport on Hell Ships, and in POW camps. [It was] an impressive commemoration, broadcasted live on national television, with thousands of people attending and the central theme: Let's continue telling their stories."
- 8/19/2024: John Schwarz received the following email from CDR Patrick Panjeti, USN, Naval Attache at the U.S. Embassy in Jakarta, Java: "Hi John, We did in fact hold a commemoration ceremony this year and the year before. Typically, the Indonesian Navy (TNI-AL) provides a vessel for the U.S. and Australian embassies to lay wreaths on the sites in Sunday pay our respects to the heroes of both ships but TNI-AL were not able to provide a ship since 2021. Instead, we hosted an hour-long ceremony on the HOUSTON and the PERTH on the U.S. Embassy grounds with our Australian colleagues. This recent commemoration included one of our own country team members, Marc Cook, gave a speech sharing his grandfather's experiences as crew member onboard's last fateful day... At the request of the Australians, the U.S. has hosted the commemoration event in 2023-24, and Australia plans to host in 2025-26, either at Sunda or at the Australian embassy if we cannot get a ship... One of our recent visitors to Jakarta was the U.S. SEVENTH Fleet Commander who I had the opportunity to discuss the history of the HOUSTON and our efforts in keeping her legacy alive. The country team requested a US Navy ship be provided for next year's commemoration and we are optimistic SEVENTH Fleet will come through for us... In other news, we have re-established an embassy working group and re-energized discussions with Indonesia's Ministry of Foreign Affairs, Fisheries and Navy to sign an MOU to make HOUSTON's site an Indonesian maritime conservation zone."
- 10/3/2024: Received word from **NG Joe Kollmeyer** that USS *Stewart* had been found in the waters off the Philippine Islands. I thanked Joe for his heads-up.
- 10/16/2024: Received the following email from the HMS Exeter group's **Tom Jowett**: "Good Afternoon All, (or evening or morning, depending where you are). I have great pleasure in advising you of the Exeter/Macassar Reunion taking place over the weekend of Saturday 1st March 2025. The [Exeter] Cathedral are yet to confirm the actual time and venue for our wreath-laying service at the "Exeter" window... (This is due to the cathedral being fitted with under floor heating, the south side & choir stalls have been completed, just "our" north side being currently 'work in progress'.) Lunch & chat afterwards has been arranged for the White Hart Hotel (just opposite the White Ensign Club)... Semper Fidelis, Tom."
- 11/2/2025: Our Association's executive director, **John K. Schwarz**, received an invitation to attend the March 1, 2025 opening ceremony of the new **HMAS Perth 1 Memorial** located in Fremantle, Australia.

## Warm Greetings From the US Navy Attaché to Indonesia

Dear Families and Friends of USS Houston,

I am honored to introduce myself as Commander Patrick Panjeti, your U.S. Navy Attaché in Jakarta since August 2022. My career in the Navy began in 1996, starting as an enlisted sailor. Over the years, I have had the privilege of serving on various combatants, gaining extensive experience and a deep sense of commitment to our Navy's mission. One of the highlights of my role here has been leading the annual commemoration of the USS *Houston* alongside my colleagues from the Australian Embassy, where we also honor the valiant HMAS *Perth*. These events are a testament to our shared history and enduring partnership.

My connection to military service is deeply personal. My grandfather, his four brothers, and his father fought bravely in World War II as Philippine Scouts under General MacArthur's command. My grandfather endured the grueling Bataan Death March, and by the war's end, only he and one of his brothers survived. This profound family history in the Pacific theater of World War II has instilled in me a strong sense of duty and a personal affiliation with USS *Houston* (CA-30) and the courageous actions of her crew.

In my current role, I am proud to be part of efforts to preserve the resting site of the USS *Houston*. The U.S. Embassy country team and I are working closely with Indonesia's Ministry of Foreign Affairs on how to establish a Maritime Conservatory Zone, ensuring the site is protected for future generations. Additionally, we are collaborating with the Indonesian Navy to restart actions to conduct a bilateral dive site survey of *Houston*, which we hope to begin as early as Summer 2025. These initiatives are crucial in honoring the legacy of USS *Houston*.

I want to extend my heartfelt gratitude to the USS Houston CA-30 Survivors Association & Next Generations for their unwavering dedication to keeping the memory of the USS *Houston* alive.



# **Robert Leon Hanley**

Seaman 2nd Class, USN



The Last U.S.S. *Houston* (CA-30) Survivor FEBRUARY 6, 1922—SEPTEMBER 12, 2024

### U.S.S. Houston (CA-30) Record

Mr. Hanley was a Seaman 2<sup>nd</sup> Class at the time of U.S.S. *Houston's* loss at the Battle of Sunda Strait on March 1, 1942. After his capture by Imperial Japanese forces on Java on March 1, 1942, Hanley and his 367 fellow U.S.S. *Houston* survivors were held on Java until October 1942 when most survivors were transported via Japanese "hellships" to Burma to work on the infamous Burma-Thailand Railway construction project. As a POW medical orderly on the railway, he assisted Dutch POW doctor Henry Hekking in saving many lives of their fellow POWS. In early 1944, he served as a medical orderly with Australian prisoners of war and was then transferred to Kanchanaburi POW Camp in Thailand where the Bridge on the River Kwai is located. There, he was a medical orderly under U.S.S. *Houston* (CA-30)'s medical officer, CDR William A. Epstein, USN. When the Japanese surrendered in August 1945, Hanley was liberated from a POW camp roughly 80K south of Bangkok, Thailand.

### Obituary: Mattson Funeral Home, Forest Lake, Minnesota

Robert "Bob" Leon Hanley, of Forest Lake, Minnesota, age 102, passed away on September 12, 2024, in Shoreview, Minnesota at St. Therese Hospice. Born on February 6, 1922, in St. Paul, Bob was a proud graduate of Humboldt High School in St. Paul, MN. Enlisting in the US Navy, Bob courageously served during World War II for five years, including a harrowing three-year internment in a Japanese prison camp. His commitment to service continued with an additional 16 years in the US Army. Bob also dedicated 15 years to 3M Company, contributing significantly to his community and country. Bob was a devout member of St. Peters Catholic Church in Forest Lake. His faith was a cornerstone of his life, guiding him through the toughest of times and the happiest of moments. A man of many passions, Bob loved ballroom dancing, fishing, and golf. His love for the outdoors was matched only by his love for his family. He married his childhood sweetheart, Eileen, and together they raised a loving family. Bob is survived by his children, Joan Filson (Bruce), Colleen Robinson, Robert Hanley (Dee), Mary Hanley, and Susan Wahlgren (Nick); numerous grandchildren and great-grandchildren who will miss his wisdom and warmth. He was preceded in death by his wife, Eileen May Hanley, his son, John Robert Hanley, and grandsons, Aaron Drews and John Grant Hanley.
