The 2025 Day of Remembrance

Association members, families, friends, and participants were among the 2025 "Day of Remembrance" (DOR) weekend attendees who enjoyed Houston's unpredictable spring weather on March 7-8. The weekend marked the 83rd anniversary of the loss of U.S.S. *Houston* (CA-30) and H.M.A.S. *Perth* (D-29) at the February 28-March 1, 1942, Battle of Sunda Strait.

Roberts, F2/c, USN (see: In Memoriam on page 20).

John also announced that there were no applicants this past year for our Association's U.S.S. *Houston* (CA-30) Scholarship Award. Also, the U.S. Naval Academy, which announces a recipient of the U.S. Naval Academy Scholarship—the U.S.S. *Houston* (CA-30) Memorial Scholarship—every other year, did not have a recipient this past year. **RADM Samuel J. Cox**, Director of U.S. Naval History & Heritage Command (NHHC), Washington, DC, who was scheduled to speak, was, in the end, unable to attend. He expressed his regrets and he hopes that he will join us at next year's DOR.

John K. Schwarz (at right) then delivered his keynote PowerPoint presentation, "U.S.S. Houston (CA-30)/POW Experience," which featured the story of U.S.S. Houston (CA-30) and the POW experiences of her survivors, including his late father **Otto C. Schwarz**.





On Saturday morning, March 8, our Association's Historian, author **Donald M. Kehn, Jr.,** (See photo at left by Dennis Flynn) delivered an engaging PowerPoint presentation entitled "Black Sunday." Don's meticulous research was clearly evident as he discussed the WWII story of the U.S. Asiatic Fleet's destroyer U.S.S. *Edsall* (DD—219) and the recent discovery of her wreckage in the Indian Ocean.

Two Australian guests, **Katie Denny** and her mother, **Robyn Denny**, then ceremoniously turned over to our Association seven U.S. coins to be added to the Cruiser *Houston* Collection at the University of Houston's MD Anderson Library on Sunday, March 9.

The story of the U.S. coins began in Thailand during WWII. The coins had been the possessions of U.S.S. *Houston* Survivor **Lyle T. Roszell**, **SEA2/c**, **USN**, who died as a POW in a Burma-Thailand Railway POW

camp in Thailand in 1943. Upon Roszell's death, the coins came into the possession of an Australian soldier and fellow POW **John Slater**. When Slater returned with the coins to Australia after WWII, he always

wanted to turn over the coins to an American POW survivor organization, but he passed away before he could, and the coins were passed down to Katie Denny, Slater's niece. Katie initially contacted our Association's Vice President Dana Charles about the coins in 2013, and made plans this year to visit America and bring the coins to the 2025 DOR in Houston. After tracking down then trying unsuccessfully to connect with Lyle Roszell's sister, Katie and Robyn decided to donate the coins to the Cruiser Houston Collection at the University of Houston's MD Anderson Library. [Dana, Katie and Robyn turned the coins over to Christian Kelleher, Director of the Cruiser Houston Collection, on Sunday, March 9, 2025—Editor].



CDR Patrick Panjeti, USN, Reports

83rd Anniversary of the Battle of Sunda Strait Commemorated in Indonesia

On February 28, 2025, the U.S. Embassy in Jakarta, alongside the Australian Embassy and the Indonesian Navy, held a solemn ceremony to mark the 83rd anniversary of the Battle of Sunda Strait. The event took place aboard the Indonesian Navy ship, KRI *Bung Tomo*, specifically for the occasion, overlooking the waters where USS *Houston* (CA-30) and HMAS *Perth* (D-29) met their fateful end during a fierce night battle against the Imperial Japanese Navy in the early hours of March 1, 1942.

Chargé d'Affaires (CDA) Heather Merritt led the U.S. delegation, joined by senior officials from the Australian and Indonesian governments and military. The Australian Deputy Head of Mission, Gita Kamath, Australian Defense Attaché, Brigadier General Micah Batt, and Navy Attache, Captain Mark Daly, underscored the deep historical ties and enduring strategic partnership between the United States, Australia, and Indonesia. The Indonesian Navy's provision of a ship to host the ceremony was a powerful gesture of solidarity and respect for the shared history of sacrifice and courage.

The ceremony for USS *Houston* began with remarks from CDR Patrick Panjeti, the U.S. Naval Attaché, who reflected on the legacy of the sailors and marines who fought valiantly despite overwhelming odds. He shared a firsthand account from Ensign Walter Winslow, one of the survivors of USS *Houston*, who recounted the harrowing final moments of the ship as it was pounded by enemy fire and eventually sank beneath the Java Sea. The story underscored the extraordinary bravery and sacrifice of the crew, many of whom fought to the last shell before the order was given to abandon ship.

Representatives from the Australian Embassy highlighted the parallel sacrifices made by the crew of HMAS *Perth*, which fought shoulder-to-shoulder with USS *Houston* until it too succumbed to enemy torpedoes. Of the 681 crew members aboard Perth that night, 353 were lost, marking the greatest loss of life in combat for the Royal Australian Navy. Survivors endured brutal captivity, with many forced to work on the Burma-Thailand Railway. The Australian Defense Attaché noted that their sacrifice remains a cornerstone of the enduring alliance between Australia and the United States.



Following the remarks, CDA Merritt and the Australian and Indonesian representatives laid wreaths in the water in a poignant tribute to the fallen. The ceremony concluded with a moment of silence and the playing of "Taps," echoing across the calm waters of the Sunda Strait.

In her closing remarks, CDA Merritt emphasized the importance of remembering the sacrifices made during the Battle of Sunda Strait and the need to preserve the site and its legacy for future generations. "Let us never forget the courage of these brave Sailors and Marines," she stated. "Through our ongoing partnerships with Indonesia and Australia, we will honor their memory and uphold the peace for which they fought."

The commemoration served not only as a tribute to those lost but also as a reminder of the importance of trilateral cooperation in maintaining maritime security and stability in the Indo-Pacific. The participation of all three nations underscored a shared commitment to honoring the past while working together to build a peaceful and secure future.


Notes on news received via email at contact@usshouston.org and via regular mail...

- 1/28/2025: Received an email from **Bailey Tucker** regarding her great uncle, **William "Billy" Edward Tucker**, whom she recently discovered was a U.S.S. *Houston* (CA-30) survivor who died as a POW in August 1943. Bailey wrote: "I only learned about him after my father died in 2020 and in his belongings I found a lot of old documents and things that my grandparents had saved, included was the letter that was sent to William's parents to inform them of his passing. My father's name is Jim Tucker, who would have been William's nephew, was the guitarist in the 60's band called "The Turtles," famous for the song "Happy Together". My grandfather's name is Tom Tucker, who would have been William's brother; he also served in WW2 and played in a jazz band called "The Bees Knees." I'm hoping to find more info about William in my documents, but a lot of the writing style from his mother has been difficult to read so far. I have only been able to locate one picture of him. From what I've read in articles, it sounds like William and possibly others would perform and play for the group to keep the spirits up during tough times while being held captive; one story I read said he made a Bull fiddle with a broom handle and empty gas drum and string. So, I saw the article about the trumpet that was recovered and thought it was pretty cool and interesting and was interested to know if there is an update with finding the owner... Thank you, Bailey Tucker."
- 1/28/2025: I emailed this reply to Bailey: "Bailey, Thank you for your email regarding your great uncle, U.S.S. Houston (CA-30) survivor William Edward Tucker, MUS2/c. I am vice president of our Association and the son of a U.S. Marine survivor of U.S.S. Houston. It is my honor to reply to your email. I am sorry for the loss of your great uncle in 1943 while he was a prisoner of war in Burma.... I am attaching a scan of Mr. Tucker's POW record, which was maintained by his fellow U.S.S. Houston (CA-30) survivors during their captivity. I am also attaching additional information about U.S.S. Houston (CA-30) and her survivors. For your information, we are running an article about William Edward Tucker in our upcoming Association newsletter, the Blue Bonnet, April 2025 issue. [See article on page 19—Editor]. Two of our Association members recently wrote the article... The trumpet, found next to U.S.S. Houston (CA-30)'s remains, resides today on display at the U.S. Naval History and Heritage Command (NHHC) after the NHHC's extensive restoration process. Its original owner remains a mystery. Thank you again for contacting us. If you have any questions, please don't hesitate to reach out to me."
- 2/3/2025: Received a photo (below) from Jane Matthews, daughter of U.S.S. *Houston* (CA-30) survivor John B. Stefanek, COX, USN, about a luncheon meeting with some family members, John K. Crewmember Spotlight



William Edward Tucker, Mus2C, USN By Joseph & Marlene McCain

William E. Tucker was one of four brothers born to Dewey and Jessie Tucker of Santa Monica, California. William, or "Billy", as his family called him, was born in 1922 and enlisted in the Navy after completing high school in 1940. By September 1941, he had been assigned to U.S.S. *Houston* as a Navy Musician. A few months later, the world was at war.

Although Mus2C Tucker was able to perform with the band ashore in the Philippines before the Pearl Harbor attacks, he no doubt spent most of his time at an assigned battle station afterward. The band did provide music for the funeral services of the 48 men lost to a Japanese February 4th bombing attack. The burial was at the military cemetery in Tjilatjap, Java.

When the *Houston* was lost in the Sunda Strait battle on the night of March 1, 1942, Billy Tucker was able to reach the shores of Java, where he was soon captured by the Japanese. From that point on, his story is a familiar one. Like most survivors, he was first held in the Serang theater building and then sent to Bicycle Camp at Batavia. By October 1942, he was at Changi Prisoner of War Camp near Singapore and, from there, was transported to Moulmein, Burma, to begin forced labor on the Japanese railway project. This occurred in January 1943.

On June 30, 1943, he is listed as being transferred to 80 Kilo Camp. 80 Kilo Camp was designated as a "hospital camp," but it had no medical facilities. Although the Japanese sent Commander William A. Epstein (the senior medical officer from *Houston*) to go with these men, he had nothing to work with. The Japanese put prisoners in this camp who were too ill to work anymore and not expected to recover. Most were suffering from tropical ulcers and were bedridden as a result.

William "Billy" Tucker lost his life at 80 Kilo Camp to complications from tropical ulcers on August 9, 1943. He was buried in the camp cemetery, grave number 29. After the war ended, his remains were brought home in June 1948 and interred at Golden Gate National Cemetery, San Bruno, California, Plot C-468. He was 21 years old at the time of his passing. Mus2C Tucker was one of two *U.S.S. Houston* band members to die in Japanese captivity. May he rest in peace.
