## **Day of Remembrance Weekend 2026**

Our Association's 2026 USS *Houston* (CA-30) Day of Remembrance (DOR) weekend will be held in Houston, Texas, March 6-7, 2026, at the Doubletree Hotel and Suites, Houston Galleria, 5353 Westheimer Road, Houston, Texas 77056. A special block of hotel rooms and a meeting room have been reserved at the hotel where we will gather to mark the March 1, 1942, loss of USS *Houston* (CA-30) and HMAS *Perth* (D-29) at the WWII Battle of Sunda Strait.

Free bus transportation, generously provided by the Harris County Precinct Three Transportation Department, will be available to and from all DOR events. On Friday, March 6, a bus will depart the hotel at 1:30 p.m. to experience a tour of the Houston Maritime Center and Museum, which contains a beautiful approximately 7-foot-long scale model of USS *Houston* (CA-30) built by Bob Ivy.

The Friday night banquet at our hotel's "USS *Houston* (CA-30) meeting room" will include a PowerPoint presentation, "The End of World War II: The Untold Story of the Surrender of Japan" written and delivered by Association member and Historian Blane Ampthor.

On Saturday morning, March 7, we will gather at 9:00 a.m. for breakfast at our hotel's "USS *Houston* (CA-30) meeting room" where our Association's Historian, Donald M. Kehn, Jr., will deliver his PowerPoint presentation, "Caught in the Iron Net—Little-known Facts About the Battle of Sunda Strait." During this

presentation, Don will be expanding upon the important information he provides in his article printed on pages 4-6 in this December 2025 Blue Bonnet issue.

At 12:30 p.m., March 7, buses will depart the hotel for the 2026 USS *Houston* (CA-30) annual Memorial Service that begins at 1:30 p.m. at the USS *Houston* (CA-30) Monument site (pictured at right) in Sam Houston Park in Houston. # Caught in the Iron Net

Little-known facts about the Battle of Sunda Strait

Although we have long understood the general contours of the final battle of **USS Houston (CA-30)** and **HMAS Perth** in the engagement off Sunda Strait on the night of 28 Feb/1 March 1942, the entire episode was far more complicated and singular than is usually realized.


In the desire to bring greater clarity and depth to the historical record, it is worth documenting a number of the more obscure aspects to that unique engagement. And certainly not based on material in online/internet sources. Sources will include original Japanese official and first-person accounts as well as rare Allied eyewitness records.

- On *Houston* a considerable number of men—exhausted by several days at Action Stations & the Battle of the Java Sea—are flaked out on the upper deck. Some sleep right next to their gun positions; some (like the teenaged Bill Ingram, powder monkey in No. 1 eight-inch gunhouse) never slept anywhere but at their battle stations & did not go below to their bunks at all. Others, like Red May, a senior warrant officer, are reluctant to use their bunks...In May's case a Japanese 20cm (8") shell fired from very long range had gone directly through his bunk's pillow during the Battle of the Java Sea. Even a few men from the black gang were on the upper deck, as it was much cooler topside. Assistant engineer officer LT Bob Fulton (USNA 1932) slept on a blanket laid out on the quarterdeck as did water tender Jack L. Smith, also Griff Douglas. They are all utterly worn out and not expecting to encounter more enemy warships ...
- Japanese cruisers attached to the Western Invasion force flew many air patrols over the Batavia area prior to the landings. Most are from RADM Kurita's *Sentai* 7 (7<sup>th</sup> Cruiser Division: *Kumano, Suzuya*, *Mikuma* and *Mogami*). But on 28 February at noon a floatplane from the light cruiser *Yura* first sights an enemy cruiser and destroyer bearing 280° 45 miles from Boomtjes Island, heading west at 20 kts on a course of 250°...This is undoubtedly *Houston* and *Perth* heading to Batavia's Tandjong Priok, but not recognized as such. Half an hour later two planes from cruisers *Kumano* and *Suzuya* track the same two enemy ships, both moving at high speed (~28 kts), and less than fifty miles distant. RADM Kurita begins to steam at speed to intercept, but...

- ...At about 1400 hrs. (JST) the floatplane from *Kumano* (Kurita's flagship of CruDiv 7) finds the two allied ships—misidentified as one *Glasgow*-class and one light cruiser—stationary about 10 miles NNE of Tandjong Priok. Kurita then decides against trying to intercept, as he believes they will have soon reached the harbor with other warships.
- At about 1530 hrs. the Japanese minesweeping unit completes its operations of clearing mines in the North Watcher passage & reports "no loose mines." The invasion convoy Army transports will be allowed to approach the coast...
- Japanese landings are divided into several different areas...Two at Merak (Area No. 1), one at Bantam Bay (Area No. 2), and one (Area No. 3) at Patrol/Eretan.
- The 34 transports at Bantam Bay go in at roughly the same time, about midnight; at Eretan/Patrol—to the east—the 7 transports do not finish entering their anchorage area until ~0140 hrs. on 1 March. The 14 transports at Merak had successfully landed their troops by 0145 hrs.

The landings at Patrol/Eretan were made to facilitate quick seizure of the Kalijati air field.

- At Bantam Bay, Japan's 5dg (5<sup>th</sup> Destroyer Division) ships are widely separated due to unexpectedly strong currents that night. Internal IJN messages refer to the problems this creates. As they enter the anchorage, they chase off small Dutch patrol boat (*Reiger*) and cause it to ground itself at 2253 hrs. (JST). Destroyers *Harukaze* (5dg) and *Hatsuyuki* (11dg) are involved, the latter firing 12 rounds of 5" at the little patrol boat. The Dutch crew abandon their vessel and swim to shore, most to be captured. (One *Reiger* officer ends up later with CA-30 survivors at Serang.)
- Around the same time, another small Dutch patrol boat, the *Sirius*, suffers a similar fate. After attempting to flee eastwards to Tandjong Priok, she is driven back toward Bantam Bay again, and there is shelled by another Japanese destroyer. Her skipper also decides to run his boat aground; *Sirius* ends up on a mudbank less than 100 yards from shore. There the crew clambered out and struggled in the heavy mud for nearly two hours before getting to solid ground...By then they could see the sea battle in full swing off Bantam Bay, with searchlights and flares briefly illuminating the darkness, the night punctuated by the heavy booms of gunfire.
- Unfortunately, no information about these actions ever reach **Perth** or **Houston** who are then
  approaching from the east...
- Within an hour *Perth* spots a strange ship (moving too fast for a Dutch patrol vessel) as she approaches
  Bantam Bay & signals are exchanged, but *Perth* receives no correct response. Knowing better than to
  delay, Waller opens fire as the Australians quickly recognize the profile of an enemy destroyer.
  After firing a reddish-colored flare, the IJN ship has turned away at speed making smoke. *Harukaze's*captain recalls this, believing their smokescreen may have helped conceal the Army transports for a
  while.




Illustration No. 48 — The Position of [the Japanese Naval] Forces Immediately After the Appearance of the Enemy Ships, and the Latter's Movements

• **Perth** & **Houston** steam toward anchorage off Bantam, although largely unaware of the transports at that point. As they do so, all heck breaks loose on the bridge of **Natori**. RADM Hara (CinC of 3<sup>rd</sup> Escort Force & 5<sup>th</sup> DesRon) gives orders to DesDiv Five (5dg) to attack with torpedoes while others try to reach him and form up.

#### Team Interviews Veterans in the Washington, D.C Area

On August 21-23, 2025, Association member Dr. Matt Fash, National Coordinator of the Stories of Service Program and Student Interview Program with the U.S. Navy Memorial in Washington, DC, assembled his veteran interview team, which included Association members Blane Ampthor and John K. Schwarz, in addition to Matt & Jeff Fash, Brian Sarris and Lieutenant David Jacoby (USN, ret).

The team's mission was to conduct interviews with two military veteran groups gathered in the area, and to work on producing a video intended to tie together elements that exist in Washington, DC related to the USS *Houston* (CA-30).

The interview team divided as the veteran group representing the USS *Ranger* (CV-61) was gathered near Dulles Airport in northern Virginia while the USS *Little Rock* (CL-92/CG-4) group was in Annapolis, MD. Both gatherings included a significant number of willing veterans who provided their individual military service stories, which will be added to both the U.S. Navy Memorial and the Library of Congress archives for permanent, historical purposes.

Production on the video commenced in the Asiatic Fleet Room located in the U.S. Navy Memorial on Pennsylvania Ave, Washington, DC. The room contains a collection of information about the Asiatic Fleet including books, paintings, pictures, and models of some of the fleet's ships. The room can be visited upon request and is otherwise utilized for gatherings and various meetings. The USS *Houston* CA-30 Survivors' Association has made significant contributions to the content of the room dating back to 1997.

In 2009 the room was re-modeled and upgraded due to a generous bequest from Sylvia Gooding Gross. Her late husband, CWO George B. Gooding served in the Asiatic Fleet as a crewman aboard the USS *Bittern* (AM-36). Held during WWII as a prisoner of war of Imperial Japanese forces, Gooding was killed as the result of the sinking of the hell ship *Arisan Maru* on October 24, 1944. Such information is preserved and displayed in the Asiatic Fleet Room honoring the memory of this fleet which made such abundant sacrifices in service to our country's miliary effort during the early months of WWII in the Pacific Theater.

When finished, the video will feature the inter-relationship of all the various elements located in and around our nation's capital which are dedicated to the memory of the USS *Houston* (CA-30). Among the elements is the relationship between the USS Houston (CA-30) Survivors' Association & Next Generations and the U.S. Navy Memorial with the U.S. Navy through its History and Heritage Command (NHHC) group. NHHC headquarters in Washington, DC houses the original ship builder's model of USS *Houston* (CA-30) as well as a *Houston* display in the NHHC-HQ lobby, which contains a display of a recovered trumpet and the bell clapper from the ship.

Also to be covered in the video is the USS *Houston* (CA-30)/HMAS *Perth* I marker, which resides on McLellan Drive in Arlington National Cemetery. Close by and in that same section 12 of the cemetery lies at rest five crewmen from *Houston*: Joseph Gans (and spouse Isabelle), Otto C. Schwarz (and spouse Trudy), John Stefanek (and spouse Irma), David Flynn, and William Batchelor. Several other CA-30 crewmen lie at rest in other sections of Arlington National Cemetery.

# Commemorating the 80th Anniversary of the Japanese Surrender Aboard USS Missouri

September 2nd, 2025, marked the 80th Anniversary of the formal end of WWII, a moment when hope for lasting peace reemerged after the most devastating war in history. The surrender ended with the stroke of a pen and words of reconciliation. As General Douglas MacArthur proclaimed, "...from this solemn occasion, a better world shall emerge... founded upon faith and understanding, dedicated to dignity, freedom, tolerance, and justice." Japanese delegate Toshikazu Kase echoed this, calling that day on the USS *Missouri* a "bright point" in the march toward enduring peace.

I had the privilege of attending commemoration events, museums, and guided tours held at Pearl Harbor, Hawaii, in conjunction with the Anniversary. Sites I visited included:

- Pearl Harbor Visitor Center Containing exhibits on the lead up to Dec 7, 1941, and the WWII years.
- Battleship USS Arizona (BB-39) Memorial The ship was tragically sunk during the Japanese attack at Pearl Harbor, with the lost of 1,177 crewmembers. Now a permanent memorial, with "Black Tears" of fuel oil still leaking from her hull.
- Pacific Fleet Submarine Museum Special exhibits on WWII, The Cold war, and The Silent Service Today World War Two Submarine Memorial – An outdoor shrine paying tribute to the over 3,000 submariners who never returned from the War. The memorial includes plaques for each of the 52 U.S. submarines lost in that conflict, as well as additional plaques representing submarines lost in accidents during the Cold War.
- Submarine USS *Bowfin* (SS-287) Launched 1 year to the day after the attack on Pearl Harbor, she was nicknamed the "Pearl Harbor Avenger". The Bowfin earned her name conducting nine war patrols during WWII, resulting in the sinking of 34 large vessels, plus 10 more under 500 tons, for a total of 213,580 tons sunk or damaged.
- Pearl Harbor Aviation Museum Situated on the actual battlefield and containing WWII hangars with restored aircraft.
- Ford Island Control Tower This Tower bears witness to the attack on Pearl Harbor and provides an elevated overlook of the Ford Island aviation battlefield.
- Hangar 79 Used for aircraft maintenance, it is a sacred space. It still bears the scars of bullet holes from the December 7th attack. The hangar stands as a silent sentinel of resistance.
- Battleship USS Missouri (BB-63) Museum Host of the formal signing of Japan's unconditional surrender
  on September 2, 1945, in Tokyo Bay, officially ending World War II. Numerous museum exhibits tell
  stories from her service in WWII, Korea, Vietnam, and The First Gulf War. I toured special exhibits
  including one on Japanese Kamikaze Pilots, and another with artifacts from the dropping of the Atomic
  Bomb on Hiroshima.
- The National Memorial Cemetery of the Pacific, located in the Punchbowl crater, honors military service in WWII, Korean War, and Vietnam War. I paid visits to the Memorial Chapel and various gravesites including the WWII journalist Ernie Pyle, and Ellison Shoji Onizuka, the first Asian astronaut to fly in space, who died in the Space Shuttle Challenger disaster.

For me, the highlights of the weekend were events held aboard, and in the pavilion alongside, the USS *Missouri*. The 80th Anniversary Commemoration Gala was held on Sunday, August 31, 2025. The Missouri was open for guided tours. A formal dinner and Presentation were held. The Gala's Speakers included: Linda Hope - The daughter of Bob Hope and Dolores Hope carries on her parents' legacy through the Hope Foundation, focusing on supporting Gold Star military families, veterans, and caregivers, while also leading efforts to honor the memory of her parents; U.S. Admiral Stephen T. Koehler - U.S. Pacific Fleet; and Clifton Truman Daniel - Grandson of President Harry S. Truman.

The 80th Commemoration Service on Tuesday, September 2, 2025, included 8 surviving WWII crew members of USS *Missouri*, all of whom were present at the surrender in Tokyo Bay and shared their experiences. Among the speakers were:

- U.S. Admiral Samuel J. Paparo U.S. Indo-Pacific Command, who delivered the keynote address.
- Gunner's Mate Second Class (GM2c) Ed Buffman From Newport, Rhode Island, Ed served aboard USS *Missouri* from 1944 to 1946 and witnessed the surrender signing.
- Emma Baksic Student Speech Contest Winner, "What Can I Do for Peace?"

Others in attendance were numerous WWII veterans from all branches of the military, A "Rosie" (female war worker), and Dorinda Makanaonalani Nicholson. She was born in Hawaii to a Hawaiian mother and Caucasian father. As civilians, they were living in Pearl Harbor at the time of the attack and stayed until forced to give up their home after the end of the war. The "Nanea Mitchell" *American Doll* was created in her honor to recognize the entry of the US into World War II after the Pearl Harbor attack and Hawaii's role in the conflict.

It was an incredibly moving experience to be present at the USS *Missouri* at the exact time 80 years after the formal surrender. Each year, the anniversary of the end of WWII reminds us of war's cost and the courage to believe in humanity, even in the darkest times. It is a reminder of our duty to remember, learn, and share with future generations the lessons of war and peace.

It was extra special to have our own Donna Flynn in attendance (Pictured above, holding photo). Her late husband, USS *Houston* (CA-30) survivor David Flynn, was given a special honor during the PowerPoint presentation, including the beautiful blown-up photo of him as provided by his son Dennis, on display throughout. It was a great day and a chance to further spread the word of what our men did in service to America.

# **New Navy Museum Site Announced**

On October 18, 2024, the then Secretary of the Navy Carlos Del Toro formally announced the site for the new National Museum of the United States Navy during a ceremony at the new museum location—just outside of the historic Washington Navy Yard, at Tingey Street and M Street. "This ceremony marks a significant step forward in our journey to reimagine the Navy Museum," said Secretary of the Navy Carlos Del Toro. "This is a testament to our unwavering commitment to preserving and honoring the rich history of our Navy, and to ensuring that its legacy continues to inspire and educate future generations."

"The new National Museum of the U.S. Navy will provide a dramatically improved opportunity for the American public to be inspired by the long history of valor and sacrifice of American sailors in the defense of our country, and to learn the vital importance of Seapower to our way of life," said Naval History and Heritage Command (NHHC) Director Samuel J. Cox, U.S. Navy rear admiral (retired). "It will showcase not only the legacy of the past, but also the global operations of the Navy today, upholding the freedom of the seas, upon which our freedom depends."

According to a press release published in September 2025, "the vision for the new Navy Museum expands the traditional museum concept to a campus layout that combines the Navy Museum, a high-tech conference center, and retail space with dining options. It is intended to be a self-funded tourist destination that aims to intrigue, inform and inspire generations of visitors...The Navy has partnered with the Navy Museum Development Foundation (NMDF), a non-profit organization that seeks to help preserve, commemorate and share the history of the U.S. Navy. The Foundation will support the museum's construction efforts and, once complete, its ongoing operation."

The Association has been informed that when completed, the new museum will display the original 14-foot-long shipbuilder's model of USS *Houston* (CA-30), which has been on display at the current Museum at the Washington Navy Yard since 2011.
